

A Logos Bible Software Search on Corporate Faith

The items below are from a basic search in Logos Bible Software for "corporate faith" to illustrate how "corporate faith" is widely used and to suggest the scope of the phrase in practice. We've also highlighted "personal/private/individual faith" wherever they happen to occur alongside "corporate faith." Keep in mind our reference model ("The Three Arenas of Faith") can be used to explain corporate faiths whose content would be unacceptable to us.
